Innovative character	"Radionica za motocikliste" and "Škola za odrasle bicikliste (18+)" are innovative in the way that we had made all new concept and approach in organising workshop for adult and senior cyclists and motorcyclist. Approach is multidisciplinary where we had involved as many stakeholders as we can (ministry of internal affairs, municipals, NGO-os, motorcyclist grups etc) and comprehensive training with professional instructors, first aid course, "shock" education by the doctor surgeon from trauma department, conversation with traffic victims etc. Workshops are free and every participant get a copy of the manual and a small gift. Issues that are addressed with the initiative	Main issues are higher level of safety for all road users and the reduction of the scope and consequences of traffic casualties, especially for the most vulnerable road users (cyclists, motorcylists and pedestrians). This year we have decline in the number of casulties in RH so now is time for action. We all made some progress from 2010. but this is not enough. 	2. Radionica za motocikliste - The basic goal through additional training to sensitize motorcyclists about the dangers of their participation in the road traffic with a focus on improper driving and inappropriate speed, also not using helmets and appropriate clothing and footwear. Our partners are ministry of internal affairs, professional driving instructors, doctor surgeon from the clinic from Clinical hospital centre member of our association who shall conduct "shock" therapy with motocyclists. First aid course should be conducted by the Croatian Red Cross - IFRC organization.	
	3. Škola za odrasle bicikliste (18+) - After two years of implementation of the project and the published manuals for cyclists, we plan to continue the workshop - School of 18+ cyclists that will be oriented towards adult drivers of bicycles in a similar format and size as well as for motorists. In addition to these workshops, we shall try to start a public debate about the rising role of cyclists in traffic and their impact and traffic regulation of their basic knowledge of traffic regulations - education for bicyclists and must wear helmets obligation in the Law on Road Traffic Safety. Adjusted first aid course should also be coducted by the CRC.	
	A multidisciplinary approach define the precise role of stakeholders in the comprehensive education of participants.Workshops shall be conducted in phases with teoretical and practical part of the education.

On the other side our projects - educational workshops for motorcyclists and cyclists are unique in their multidisciplinary form and holistic approach in education in theoretical and practical phase. From the latest WHO and ETSC statistical data, EU statistical pocketbook as well as data from our national institutions are showing that most vunerable participants in traffic had made a small step forward toward the Decade of action goal of reducing road traffic accidents in half. That is why our activities are up to date with the latest situation throughout EU. NGO system of volunteering in organisation of activities is reducing the cost of the projects so it can be easily introduced in every country in EU.
