

RS education in schools:

5 questions

- When do we start?
- What is the content?
- How to do it?
- Who can provide it?
- Possible outcome?









When do we start?

- Children are part of traffic from a very young age onwards
- Informal learning begins before entering school











When do we start?

Age 5-7

Children are typically given limited responsibility for their own safety.

- Understand that crashes can lead to getting hurt.
 Be aware of the dangers of not being seen
 - because of stationary vehicles or other obstructions.
- Identify safe play areas and learn how to play safely
- Understand the importance of being visible in day and night and in all types of weather.
- Recognize and seek people who are present to help cross the road.
- Understand traffic lights.
 Use visual and auditory clues to recognize the direction from which traffic is coming
- Stop, look and listen before crossing a street.

Age 8-12

European

Children are often expected to deal with traffic risk by themselves.

- Be aware of importance of planning safe school routes.
- Know when and how to summon help in an emergency.
- Recognize the need to be visible near and in traffic.
- Recognize the varying speeds at which different vehicles and people are moving.
- Know that traffic rules are not always observed by other road users
- Understand which road signs are warnings that must be obeyed and which provide information.
- Set a good example for other children.
- Understand that stationary vehicles compromise visibility
- Understand that domestic and wild animals on roads cause accidents.

What would be the content?

Age 13-16

Children are supposed to act independently in a traffic situation.

- Be alert when using public transport alone.
- Ride a bicycle safely.
- Know the rules of the road and responsibility to fellow road users
- Identify and understand causes of road crashes and how to reduce risks.
- Be able to judge speeds and distances.
- Know simple first aid.
- Being aware that walking and riding in group could be more dangerous.

Age >16

This group is preparing themselves to use motorized vehicles.

- Knowing all the rules for bicycle and moped riding.
- Preparing for a drivers' license.
- Be aware of there own impulses and drives and the link with safe traffic behavior.
- Develop scoping skills to resist to group pressure and challenging peers.
- To take responsibility over younger children in traffic.
- Recognize that alcohol, drugs and fatigue contribute to road crashes.



Effects of RS education

- Effects on knowledge and competences >< effects on attitudes and behavior in a traffic situation.
- Effects most visible in a short time after intervention.
- Formal RS education has an impact, but also other things: parents, media, peer group, ...
- Behavior depends also of the circumstances / environment!



Focus on competences that are needed at that age, situation, ...

It is a continuous process: being a safe pedestrian as a child does not mean that he will be a safe driver in the future!









Be a safe pedestrian!

Road safety educational project for kindergarten/preschool and primary school children (first grades).







Starting point

- Analysis of traffic accident in Brussels region (2000-2009)
 - Children as pedestrian:
 - 57% of fatalities
 - 79% of heavily wounded
 - Pedestrians were...
 - 71% while crossing a street
 - 22% on the side walk







Plan: Pedestrian Certificate Project

Objectives:

- How to behave on the side walk
- How to cross the street

3rd year of preschool

1st and 2nd year of primary school

- Learning conversation
- Observation in the street
- 'theory course' in class









General overview

- Psychomotor exercises
- Practicing the safe behavior
 - With toys
 - On the playground
 - In the street with the teacher
 - (In the street with the parents)














At the end, children can get a kind of certificate if they have reached certain age-specific goals.




10 to 12% of all work-related incidents happen in traffic


2013 traffic accidents during work hours and commuting



- 11 billion euro for insurance companies
- 1,5 billion euro to victims

For each euro spend on direct costs.... There are 10 euros spend on indirect costs.





Safety Culture

...describes the safety ethic in an organization or workplace which is reflected in employees' beliefs about safety and is thought to predict the way employees behave with respect to safety in that workplace.

Ann Williamson, 1997





Safety culture

- Visible leadership commitment at all levels.
- Pro-active instead of re-active approach
- Lack of competing priorities (being 'fast' versus being 'safe')
- Substantial investment and resources.
- Safety is viewed as an investment, not as a cost.
- Motivation and 'enforcement'.


